

RFM Program of Work for Standards - May 2015 - Dec 2016

ASMI intends to review and re-edit the RFM Conformance Criteria V 1.2, September 2011. The outcome should be a V 2 of the Standard.

The scope of the Standard will remain unchanged and the geographic application will remain unchanged.

The objectives that the Standard seeks to achieve remain unchanged and are listed in the RFM Quality Management System. GSSI Benchmarking approval is a new objective.

There were no changes to Standards in the last six months. ASMI has been reviewing Procedure and Document Control in the last six months and benchmarking and editing these Procedures to meet GSSI Benchmarking Requirements.
