Chain of Custody Standard Self-Assessment Checklist

Chain of Custody Standard Self-Assessment Requirements

This document details a set of requirements which permit a self-assessment to be conducted against the key criteria of the RFM Chain of Custody Standard. This allows applicants to ensure that a seafood product put on the market and bearing the RFM seal is genuinely a product of designated origin and originates from the certified fisheries concerned. These measures thus cover the tracking and traceability of the product from the harvester to the first point in the supply chain either inside or outside of the State of Alaska. ¹

Please note- if an applicant cannot provide evidence that they source 100% of all their seafood from a RFM Certified Fishery(ies) they cannot use this self-assessment mechanism and shall need to have a full RFM CoC on site audit completed prior to them having the right to use the RFM Seal and certification claim.

	used for their despatched products to	
	ensure they include the following (this is not	
	an exhaustive list):

3.9	The applicant shall, on request, be able to produce accurate traceability records maintained for the duration of the shelf life of the product, or three years, whichever is the longer
