**The scope of certification is:**

**Applicant Group:** Alaska Cod Fishery Client Group

**Product Common Name (Species):** Pacific cod (*Gadus macrocephalus*)

**Geographic Location:** GOA and BSAI within Alaska jurisdiction (200 nm EEZ)

**Gear Types:** Bottom trawl, longline, pot, and jig gears

**Principal Management Authority:** Federal (NMFS and the Council) and state (ADFG and BOF)

Stakeholders are invited to comment on the factual contents of the report, either in relation to the specific sections of the report or specific scoring rationales or indicators. Comments should be clearly related to specific report sections or scoring rationales or indicators. Any recommendations or criticisms should be supported with data or literature citations so that the assessment team can evaluate these comments.

Following receipt of comments from stakeholders, DNV will consider all available information and make a determination on whether the fishery should be certified. Following this determination, the final report will be made available.
