This review was carried out over 3 months and included a structured review of RFM procedures, policies, website and reviews of CB operations and records. The comments and findings from this review are intended to be used to inform the RFM Management and advisory committees, on what areas of the Program have been reviewed both internally and externally and those that are working well and what areas of opportunity there may be for Program and/or policy and procedural improvements.

This review helps the RFM Program to meet its commitments to the GSSI standard and review process – re Scheme Integrity

The review covers the areas of

- Scheme performance
- Performance of certification and accreditation bodies.
- Review Application to Certification Procedures
- Review of QMS and Governance
- Committee membership and meetings
- Programs of work
- Complaints and appeals

The review was conducted over 3 months by the RFM support team / external consultants.

I. Overall Program Headlines

Program Scope: The geographic scope of the Fishery Standard has been extended. The governance committees of the RFM Program agreed in 2024 to extend the scope of the

Program and the Fishery Standard to beyond North America and to international adaptation.

This decision resulted in the RFM Fishery Standard version being updated to extend geographic scope but as no standard clauses were changed this did not constitute a full new issue of the standard.

The scoring guidance documents have been revised to make terminologies and references more applicable for fisheries outside North America. No fisheries outside North America have applied for certification at the time of this review.

GSSI were informed of the scope decision before this was publicly announced in 2024.

Certifications Review: All four certification bodies have been audited by the RFM Team in 2024 and were found to be in compliance with the RFM guidance and expectations.

All CBs have also been audited by their IAF accreditation bodies.

One new certification body (Control Union) is in application for accreditation extension to the RFM Standard.

One new fishery was certified in 2024. The Gulf of Mexico Shrimp fishery was certified by NSF/Global Trust. The Client is the American Shrimp Producers Association.

There has been no significant increase or decrease in the number of Chain of Custody certifications in 2024.

Complaints - The Program has received no external complaints.

VIII. Committees within the RFM Program

- The RFM Fishery Standards Committee which is a change from the Conformance Criteria Committee (CCC), an international multidisciplinary group of experts who formally and periodically review the Fishery Standard and Scoring Guidance document.

Unified Chain of Custody Technical Advisory Committee (TAC)

IX. RFM External Program Assessment Review

CSC has been active in the GSSI (Global Seafood Sustainability Initiative) review and became the first re-approved program in 2023 after an external expert review and public comment process.

The RFM Quality Management System (QMS) is currently being reviewed via the GSSI MOCA audit review. This will be concluded in Q1 2025 and current findings (Feb 2025) show the Program to be in alignment

All RFM QMS Procedures were found to be aligned with GSSI and during the GSSI audit

The RFM Team are expected to keep GSSI up to date with key changes and also respond to requests for information.

XV. Certification Body (CB) Management

Based on 2024 CB reviews the CBs are performing to expectations and RFM Criteria.

Global Trust /NSF – RFM Fishery and Chain of Custody

A 2024 review took place remotely on 28th Nov 2024. The accredited office is Dundalk, Ireland. The CB has certified four fisheries Salmon Recert / Golden King Crab, P.Cod, US Gulf of Mexico Shrimp and of Chain of Custody certifications internationally.

Overall –Zero Non conformances were recorded.

AB is INAB and have completed annual audits.

SCS Global – RFM CoC Only

The SCS accredited office is in Emeryville, California.

The 2024 CBreview took place remotely on 17th October 2024 SCS carry out approximately 22 CoC audits. Most audits are joint MSC/RFM Audits

A number of minor Non-Conformances were raised. The issue behind most NCs was that the CB were following MSC certification requirements and directives rather than RFM. Observations had been incorporated into SCS procedures and they are not part of the RFM Program.

Overall – All NCs are closed out. Performance could be improved. AB is ANSI.

DNV Global – RFM Fishery Only

The accredited DNV office for the RFM Program is Katy, Texas. This address details and accreditation number are accurate on the ANAB accreditation certificate.

The Accreditation Body (ANAB /ANSI) audit entailed reviews of a number of general quality management programs and some specifics of RFM Program.

A 2024 review was conducted August 14th 2024.

No Non conformances were raised and the procedures and controls were well maintained The CB is certifying three fisheries against RFM Standard - Pollock, Sablefish, Halibut **Overall** – performance is good

AB is ANSI.

MRAG Americas

The accredited office is St Petersburg, Florida.

MRAGs review was conducted on 24th September 2024. Zero non conformances raised.

The CB has received accreditation via ANSI for Fishery and CoC. Non-conformances raised by the AB have been closed

The CB certifies three fisheries and only a small number of CoCs have been issued.

They hope to expand their activities.

Overall - Quality of documentation was good
